Overview

The department provides essential services involving vital records, including:

- Copies of birth, death and marriage certificates
- Issuing marriage licenses
- Recording real property records
- Filing fictitious business name statements
- Filing notary public oaths and bonds
- Overseeing the Orange County Archives

Real Property Records

The department is responsible for examining and recording documents that establish ownership of land in the county. For public access, the department also maintains a permanent record and index of documents, including grant deeds, abstracts of judgment, reconveyances and liens. As an added service, homeowners are sent courtesy notices alerting them of transactions affecting their properties.

Electronic Recording



Orange County is a statewide leader in the electronic recording of property documents. Among its innovations is the development of a multi-county electronic recording system called SECURE. This award-winning system is co-owned by the counties of Orange, Los Angeles, Riverside and San Diego. Customers such as title

companies and lending institutions are able to submit documents to each participating county from a single computer screen.

Marriage Services

Couples needing marriage licenses and civil marriage ceremonies can visit any of three charming locations: the Old County Courthouse in Santa Ana (seen below), Historic Downtown Fullerton and the Laguna Hills Civic Center. Each ceremony room has ample space for guests. Marrying couples may obtain a license and have the ceremony performed on the same day. Our Westminster location also offers marriage licenses only. Birth and Death Certificates

The department maintains and issues certified copies of birth and death certificates in the county. Copies can be requested in person, online and by mail, phone or fax at least 60 days after an event. (Copies needed within 60 days of an event may be obtained from the Orange County Health Care Agency). Copies of birth and death certificates are available at any of the department's convenient locations in Santa Ana, Fullerton and Laguna Hills.
